Dear organizers of the conference on welfare of Tamils in Eelam,

World Tamil Organization (WTO) is a Non-Profit organization registered in the United States of America. Since its inception in 1991, WTO has been espousing the cause of Tamils wherever they live.

While welcoming the upcoming Tamil Eelam Supporters Organization (TESO) Conference to be held in Chennai to ameliorate the sufferings of the Tamil people living in Sri Lanka, World Tamil Organization (WTO) impresses on the organizers of the Conference the following for a permanent, lasting solution:

1. The only solution is an independent, sovereign state of Tamil Eelam in the ancestral land of the Tamil people in the Island of Sri Lanka. The Tamils have been living in the North and East of the Island (here after referred as Tamil Eelam) from time immemorial. A referendum must be conducted for Tamil Eelam under the supervision of the United Nations, as was done for many Nations that became independent, sovereign countries recently.
2. While conducting referendum for Tamil Eelam, all the Tamil people who were forced to leave Sri Lanka and their descendants must be allowed to vote.
3. The State-sponsored Sinhalese who were settled in the Tamil homelands under the sponsorship of the Lankan Government and their descendants should not be allowed to vote in the referendum for Tamil Eelam.
4. The Sinhalese leadership that perpetrated horrendous crimes and genocide against the Tamils must be brought to stand trial, without delay, in the International Court of Justice in The Hague.
5. All the lands confiscated from the Tamils must be returned to their rightful owners.
6. The plantation Tamil people have every right for citizenship and they have every right for equality.
7. Pay homage to the hundreds of thousands of Tamils who perished in the war.

8. The Eelam Tamil refugees in India are being treated very badly, under horrible, inhumane conditions. They must be treated with the same dignity, respect and privileges that are enjoyed by the Tibet refugees.
9. TESO must organize an All Party Conference in New Delhi as soon as possible to convince all the Indian political parties that Tamil Eelam is the only solution and that India must recognize Tamil Eelam. India which established Bangladesh for the Bengalis must do the same for the Tamils in Tamil Eelam.
10. Any financial aid that India gives to the Tamil people in North East of Sri Lanka should not be sent through the Sinhalese Government in Colombo, but must be channeled through recognized international aid agencies such as Red Cross.

World Tamil Organization fervently hopes that the TESO Conference seriously consider the above recommendations and take suitable actions.
