It is pertinent that the High Commissioner Ms. Navi Pillay on her report to the UN Human Rights Council dated February 11 has clearly and unambiguously called for an '*Independent, credible International Investigation*' for the mass atrocities committed against Tamil civilians in Sri Lanka.
